- 4. In case of non commencement of the project or non completion of the same within the stipulated period or if the report is found to be not satisfactory, the entire released amount shall be recovered from the concerned Principal Investigator with admissible interest.
- 5. The report along with the accounts shall be submitted to the Directorate PMEB immediately after its completion.
- 6. An undertaking on the same may be given by the principal investigator while releasing the amount.
